The matter regarding the revision of honorarium rates for the engagement of Honorary Visiting Specialists (HVS) in the Railways has been under consideration of this office. The revised honorarium rates, along with the provision for deduction in remuneration for any absence exceeding 12 days, as concurred by the Finance Directorate, are as follows:

1. **The Revised Honorarium for HVS and Daily Rate of Deduction of Remuneration:** The revised honorarium rates and the deduction rates for any absence beyond 12 days for engagement of HVS are as under:
